#### Athletic Recognition

#### Meet our Students

Tonight I have invited Daniel Benevento to speak with you about his experience as a student at Gloucester County College. Mr. Benevento began his journey at GCC in January, 2009 and will be graduating this May with a degree in Liberal Arts/Elementary Education. He managed to complete his degree requirements in one short year, achieving the President's list every semester. #### **Grant Award**

#### Instructional Center Renovations

#### Food Service Management Lease

On the recommendation of the President, Mr. Keller made a motion, seconded by Ms. Ross and unanimously passed, to authorize the Vice President of College Operations to negotiate the terms and conditions of the food services lease with Chic-fil-A of Atlanta, GA and present the contract for the President's signature.

#### Data Center Renovation Project

On the recommendation of the President, Mr. Keller made a motion, seconded by Mrs. Abele and unanimously passed, to reject the bids submitted due to incurable defects in the bids and rebid as soon as possible for data center room engineering renovations.

#### Fiber-Optic Backbone Project
