### REGULAR SESSION MINUTES December 19, 2016

Chair Gene J. Concordia called the Regular Session of the Board of Trustees of Rowan College at Gloucester County to order at 6:15 p.m. in the faculty/staff lounge in the Eugene J. McCaffrey College Center building.

Chair Concordia greeted everyone and thanked all for participating. He then offered congratulations to Mr. Len Daws on his reappointment by the Freeholders to a four year term on the RCGC Board of Trustees.

Chair Concordia informed all that Ms. Yolette Ross had resigned from the Board of Trustees and he acknowledged her dedication and service to the College during the past 16 years. Ms. Ross served as the Board's Vice Chair for the past six years so he opened the floor for nominations for the position of Vice Chair to serve the remaining term. Ms. Jean DuBois nominated Mr. Douglas Wills, seconded by Mr. Benjamin Griffith. Trustee Griffith moved to close the nominations and Trustee DuBois seconded the motion. The motion to appoint Trustee Wills as Vice Chair was unanimously passed. Trustee Wills was declared Vice Chair.

Trustee Wills was the Board's Treasurer and Chair Concordia opened the floor for nominations for the position of Treasurer to serve the remaining term. Trustee DuBois nominated Ms. Ruby Love, seconded by Trustee Griffith. Trustee Griffith moved to close the nominations and Trustee DuBois seconded the motion. The motion to appoint Trustee Love as Treasurer was unanimously passed. Trustee Love was declared Treasurer.
