CG 215: Electronic Illustration I

Syllabus

Lecture Hours/Lab Hours/Credits: 2/2/3

Catalog Description

Prerequisite: CG 115

In this course, students learn to use a vector drawing program to create graphics on the computer. Focus is on creating object-oriented drawings using type effects, Bezier drawing tools, gradients, symbols, colors, and correct use of file formats. Students create drawings for print, screen, and the web, and demonstrate a mastery of the use of the basic menus, commands, and tools of electronic illustration software. All lecture topics are supported by a lab component.

9. **Ethical Reasoning and Action:** Students will understand ethical issues and situations.
10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
