This course introduces advanced techniques of authoring games and interactive design projects. Students learn advanced tools and begin to use professional design tools to design prototype game and interactive products as well as the application of interface design principles. Students complete projects that demonstrate the use of the skills and techniques learned in this class.

8. **Global and Cultural Awareness:** Students will understand the importance of a global perspective and culturally diverse peoples.
9. **Ethical Reasoning and Action:** Students will understand ethical issues and situations.
10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
