## **TH 209 Singing for the Actor II**

Syllabus

Lecture Hours/Credits: 3/3

### **Catalog Description**

*Prerequisites TH 104 Singing for the Actor I*

This course is a continuation of vocal and performance techniques required to meet the demands of singing for the theatre. A practical course, students will work on musicality through sight singing, singing harmonies, breathing techniques as well as learning how to analyze a song as dramatic form and “sell it” in audition or performance. Students will leave class prepared with three audition pieces for musical theatre. Students will interpret assigned material, determining a process to bring a song to performance level, and illustrate the musical theatre canon through sight-singing, work-shops, and performing.

### Topical Outline

This class is a continuation and collaborative workshop to include the following:

- 1) *Group warm-up*; getting our bodies and voices warm, and demonstrating the basics of singing.
- 2) *Individual song work*; interpreting each song both from a technical and dramatic standpoint, illustrating character, story, and presentation.
- 3) *Class interaction*; formulating acting exercises to help each singer tell the story, involving other class members.
- 4) *Group discussion*; as the individual songs take shape, the class will discuss varying ways in which these songs might be performed. We will then begin to create a show - deciding on the order of songs, possible themes, common threads among songs, and staging - using ideas that may emerge from the class interaction above.
- 5) *Rehearsal of final project*; once the show is created, the final weeks will be geared towards running it from start to finish, finding a flow and pacing, and making any necessary changes.
