### CR 108 Clay CO-OP Experience – Studio

Syllabus Lecture Hours/Credits: 3/3

### **Catalog Description**

CR 102- Ceramics II and CR 106- Ceramics Technologies

Focuses on all facets of studio management including how to keep track of inventory, how to maintain and order supplies, and how to run a safe and efficient studio. Students will meet with the instructor of Ceramics III, who will organize the work schedule. Students are expected to work four hours a week for fifteen weeks in the studio.
