## **Catalog Description**

Prerequisites: EN 102

EN 210 is a survey course of American literature from mid-nineteenth century – Age of Realism – through mid-twentieth century literature. Since the purpose of a survey course is to study those authors contributing the most significantly in the widest possible range, the focus in this course is on the major authors of each period, yet writers of lesser stature are not excluded.

- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
