Topical Outline

- Correct usage of the diaphragm and deep breathing.
- Support of tone production and freedom from tension.
- Formation of pure vowels using the articulators: the tongue, lips, jaw, teeth, hard palate and the soft palate.
- Vocal timbre (tone quality steady, rich, resonant, sympathetic, thin, nasal, etc.)
- Vibrato control the pulse or wave in a sustained or straight tone.
- Voice placement lower and upper registers.
- Learn proper stage deportment for correct stage presence.
- Summarize all of the above to reproduce beautiful vocal literature that is aesthetically pleasing both to the singer and the listener.
- Perform in the student recital at the end of the semester (music majors only).
