TH 104 Voice for the Actor I

Syllabus

Lecture Hours/Credits: 3/3

Catalog Description

This course focuses on the techniques of effective voice and speech production and development of the student's vocal technique and awareness of the vocal process through exercises in relaxation, body alignment, and support of tone and placement of sound. Emphasis on freeing the vocal apparatus of tension, extending pitch range and developing greater responsiveness to language values will be explored throughout this course.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.

Topical Outline

- Voice, text and rehearsal onstage with an audience
- Re-creating the work consistently again and again
