Acting II focuses on the continuation and practice of acting with an emphasis on practical experience in problems of creating characterization and scene preparation through textual analysis. Vocal and physical skills are further developed through a performance driven course of study where students are exposed to a range of techniques and styles explicated by primary acting theorist/practitioners.

- 9. Ethical Reasoning and Action: Students will understand ethical issues and situations.
- 10. **Information Literacy:** Students will address an information need by locating, evaluating, and effectively using information.
