Students must be 15 years old or older and have completed freshman year of high school. Students may utilize HSOP through the spring semester of their senior year. However, students age out after 18 years of age. Students must submit an official high school transcript.
Students must satisfy the placement test requirements by taking the College's placement exam, the Accuplacer or by submittin qualifying SAT, PARCC and/or ACT scores. RCSJ Student IDs are issued upon submission of the HSOP Participation Form and is required to schedule the Accuplacer. Please refer to <i>RCSJ.edu/gc/Testing</i> for more information.
HSOP courses are offered at a discounted rate on tuition and per-credit fees to unlimited number of courses. Additional course required materials, textbooks and other fees are not included in the discounted rates.
